DIRECTORS' REPORT

The Directors have pleasure in submitting their Report together with the audited financial statements for the year ended 31st December 2010.

1. Principal Activities And Operating Review

The principal activities of the Company in accordance with its Memorandum and Articles of Association are to provide a National Concert Hall for the promotion of Concerts and Recitals of Musical Works of Artistic, Educational or Cultural value, to provide facilities for practice, rehearsals and performances by the National Symphony Orchestra, to promote and encourage the performance of music and other artistic performances to the highest standards.

The operating review is outlined in the Chairman's Statement.

2. Results For The Year

The accounts for the year ended 31st December 2010 are set out on pages 10 to 15. The results for the year on ordinary activities before taxation show a surplus of €183,663 after meeting all working expenses including Chairman's Remuneration of €9,450 and after providing for depreciation of €24,289.

3. Reserves

The surplus on Profit and Loss Account amounted to €1,916,342 at 31st December 2010.

4. Directors

The Directors hold office for a period of five years to May 2011. On the expiration of the said five year term they are eligible for re-appointment.

5. Safety, Health And Welfare At Work Act 2005

It is the policy of the company to ensure the health and welfare of employees by maintaining a safe place and system of work. This policy is based on the requirements of employment legislation, including the Safety, Health and Welfare at Work Act, 2005.

6. Auditors

The Auditors, Hayden Brown, Chartered Accountants, will continue in office in accordance with Section 160{2} of the Companies Act, 1963.

7. Statement Of Directors' Responsibilities

Company law requires the directors to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period. In preparing those financial statements, the directors are required to :-

- Select suitable accounting policies and then apply them consistently.
- Make judgments and estimates that are reasonable and prudent.
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure that the financial statements comply with the Companies Acts 1963 to 2009. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities..

8. Books Of Account

The measures taken by the directors to ensure compliance with the requirements of Section 202, Companies Act, 1990, regarding proper books of account are the implementation of necessary policies and procedures for recording transactions, the employment of competent accounting personnel with appropriate expertise and the provision of adequate resources to the financial function. The books of account of the company are maintained at The National Concert Hall, Earlsfort Terrace, Dublin 2.

CHAIRMAN'S STATEMENT



I am happy to report, in this my fifth and final Annual Report of the current Board's five-year term of office that the National Concert Hall has once again performed exceptionally well in what was a most challenging year from both economical and meteorological perspectives. In January, November and December 2010 the country experienced heavy snowfalls whilst in April 2010 we coped with the volcanic ash clouds and yet still maintained to host a record 834 events at the Hall for the year. Attendances in 2010 totalled 318,667 and were only marginally below the previous year's record. Box office sales were very buoyant at €7.13 million. The financial results again exceeded Board expectations and reflected a very strong management performance. In a year in which consumer spending experienced sharp contractions, the National Concert Hall recorded profits of €183,663.

Some of the orchestral performance highlights in the past year included visits from the Hallé Orchestra, Luxembourg Philharmonic Orchestra, London Symphony Orchestra and Philharmonia Orchestra, as well as another year of outstanding performances from our own RTÉ National Symphony Orchestra and RTÉ Concert Orchestra.

We were also visited by many world-renowned artists including Lang Lang, Sarah Chang, Janine Jansen, Midori, Finghin Collins, Angela Hewitt, Ivo Pogorelich, Tasmin Little, Paul Lewis, Anne-Sofie Von Otter & Cecilia Bartoli.

Other programming highlights included the 6th Veronica Dunne International Singing Competition, Ronan Tynan, Brian Kennedy, Philip Glass, The Beach Boys, Tom Paxton, Arlo Guthrie, John O'Conor, Jools Holland and his Big Band, Kenyan Boys Choir, as well as the operas Madama Butterfly, La Traviata & The Mikado. The National Concert Hall also partnered with the RTÉ National Symphony Orchestra in a charity concert for Haiti where the proceeds were donated to help victims of the earthquake.

The National Concert Hall continued its programme of contemporary music facilitating music projects with various groups including the Irish Composers Collective, NewSoundWorlds, Crash Ensemble, Roger

Doyle as part of the Dublin Fringe Festival, the Contemporary Music Centre as well as showcasing new works by Irish composers and by supporting emerging Irish talent highlighted in the 'Rising Star' concert in January.

The ESB Live series began in May, with a much acclaimed performance by Julie Feeney with Orchestra followed in September with a performance by Dervish with special guests Moya Brennan, Martin Hayes, Dennis Cahill and Damien Dempsey. Cerys Matthews and Afro Celt Sound System completed the series line up in November.

The National Concert Hall also continued its concerts for the St. Patrick's Festival and included performances by the Kilfenora Ceili Band and the Kodo Drummers. A separate new pilot initiative called Soilse na Nollag took place in December which featured traditional artists & instrumentalists performing over six days which proved most successful.


In September, the Hall presented the 1927 Fritz Lang film 'Metropolis' to orchestral accompaniment and conducted by Helmut Imig.

The National Concert Hall also celebrated National Science Week with a performance of 'Apollo' by Brian Eno and performed by Icebreaker and BJ Cole.

The Friends Opera Gala was held in November 2010 and featured a concert by soprano Nathalie Manfrino. The 'Snowman Movie' series of concerts held in December with narrator and childrens TV presenter Brian Ormond was yet again a great success with our younger audiences. Fully staged performances of Disney's Beauty and the Beast were also a huge hit with our younger patrons.

In addition to these concerts, the Hall was host to assorted mixes of performance types as diverse as opera, choral, organ, traditional, big band, jazz, world music, popular, musicals and children's events.

The National Concert Hall puts a strong emphasis on teamwork, trust and integrity and I am proud to say that the management formally embedded these characteristics into the organisational culture of the Hall by developing a National Concert Hall best management practices programme. It involved developing a set of best management

practices relevant to the National Concert Hall where all managers and supervisors in the organisation are rated by their subordinates confidentially on the use of those practices. Over time the programme will allow the Board and its senior management team to monitor the evolving culture of the organisation.

The management of the National Concert Hall also designed a second programme entitled 'TeamWorks' which encourages its employees through team participation, to generate innovative ideas or proposals that will improve work processes. This programme promotes employee involvement, team building and team development, creative thinking and continuous improvement both for the individual and for the organisation and I am happy to report that it has been a runaway success.

The Board applauds the drive, spirit and commitment of its management team to remain at the forefront in organisational development by creating a culture of continuous learning, improvement, development and growth in which all members of staff are encouraged to develop their skills and talents.

In 2010, The National Concert Hall's Learn & Explore Programme presented 355 on-site and 259 off-site events. The Hall offered a wide range of programming and learning opportunities for older people, children and families, schools and teachers, people with special needs, musicians and music students.

2010 saw the continuation and expansion of the Blow the Dust Orchestra project which encourages creativity, activity and team building in older musicians. Highlights included a performance in Heuston station for the Bealtaine festival launch in April and an open-air concert in Meeting House Square for Temple Bar Cultural Trust's Summer Sensational festival in July. The National Concert Hall was also successful in securing North-South funding, which involved the orchestra working with composer Neil Martin and the West Ocean String Quartet on workshops and open rehearsals at both the National Concert Hall and the Waterfront Hall, Belfast.


The Hall continued to offer a series of workshops for toddlers and their parents & older children, encouraging hands-on learning of styles,

rhythms and the variety of orchestral instruments. Our summer camps for young people expanded beyond the 7-9 age range of previous years, with the introduction of Songschool for young musicians and songwriters aged 13-17. The Hall supported high-quality music education across Ireland, including Meitheal traditional music summer school in Limerick, the Samhlaocht festival in Kerry, the Con Brio series in Sligo, Adventures in Music in Galway, The Frankie Kennedy Winter School in Donegal and the WhistleBlast Quartet's work in Mayo.

The National Concert Hall's strings programme continued to provide expert mentoring to schools with their own grassroots orchestral projects and expanded into more schools in Dublin, Cork and Kildare. The Hall presented a five-day training programme for primary teachers as well as visiting 7 counties with the 'Up the Tempo' project. These week-long primary school residencies, workshops and free teacher training saw the completion of the project, having visited every county in Ireland over the past 5 years. Special performances of the Leaving Certificate Music syllabus Set Works were offered, to give fresh insights into the works for students and teachers alike.

The National Concert Hall continues to support the good work of sound artist Slavek Kwi at Temple Street Hospital and St Declan's School who works with children on the autistic spectrum. Separately from this, our Kids Classics programme brought monthly interactive music workshops to the three main children's hospitals in Ireland. In partnership with Waterford Healing Arts Trust (WHAT), the National Concert Hall supported monthly music programmes in Waterford Regional Hospital for patients in the Renal Dialysis Unit. We also provided bimonthly, outreach workshops for special needs groups, including Enable Ireland and St. Michael's House.

The National Concert Hall continued to engage music students and amateur musicians through a range of events. The inaugural 'Bernadette Greevy Bursary for Singers' was presented, awarding a prize of €5,000 toward furthering musical development. We also awarded the 5th annual Jerome Hynes Commission Opportunity for Young Composers, giving young musicians a platform to showcase their talents. The Hall also programmed 'Choral Singing Clinics' which built amateur choristers' skills and encouraged best practices and great performances across the vast amateur choral community in Ireland.

We also continue to provide opportunities for young musicians and the public to learn from the masters with our very popular masterclass series.

Throughout 2010 I am happy to report that the National Concert Hall continued to improve its technical facilities for the benefit of patrons, promoters and performers alike. A large scale production lighting network upgrade delivered an industry standard LED lighting system for the main auditorium which adds greatly to the production value of events and which facilitates the staging of more technically sophisticated concerts. It also eliminates any health and safety risks associated with the previous lighting system which called for manual focussing at high level. Complementing this installation was the introduction of remote profiling lamps incorporating moving shutters allowing instant access to overhead specials on stage. Specialist microphone kits specifically created for use with strings and woodwinds were also acquired along with digital multi-track recording equipment which provides the facility of digital recordings from the main sound desk which can then be digitally re-mixed and mastered in studio.

An outdoor coffee dock at the front steps of the Hall was opened during the year which extends and enhances the dining experience for visitors and patrons by offering a tailored alfresco menu throughout the day.

During 2010, audience development remained one of our core objectives with a significant increase in the number of first time visitors. The broadening of our programme of events and the expansion of our education and outreach activities also made a key contribution in attracting new audiences.

Customer Research ensured that value for money was kept at the forefront of the Hall's pricing strategy and the maintenance of our 'no booking charges' policy helped the Concert Hall to continue to remain accessible to all. The National Concert Hall was the proud recipient of an eGovernment award in 2010 for its online sales channel www.nch.ie, which reflects the vibrant growth both in visitor and online booking activity experienced during the year.

Corporate sponsorship remained challenging in 2010 due to the general economic downturn and I wish to recognise the great contribution

made by our Corporate Associates who unfailingly continue to support the Hall.

The Friends of The National Concert Hall continue to play a key role for us and the very diverse range of activities which were held specifically for this core group were typically filled to capacity. Our activities would almost certainly have been significantly reduced without the strong support shown by the Friends.

I wish to acknowledge the unstinting support received both from the Government and particularly from the Minister for Tourism, Culture and Sport, Mary Hanafin and thank both for their inspiration and guidance.

Sadly the Government were not able to proceed with the Public Private Partnership project to redevelop the National Concert Hall due to economic reasons. With the Board of Directors and the OPW, I am confident that we can influence Government in proposing to refurbish the current auditorium which desperately finds itself in need of essential repair and to redevelop a smaller 500 seater space for recitals.



AUDITORS' REPORT

Respective responsibilities of directors and auditors

As described on page 2 the company's directors are responsible for the preparation of the financial statements in accordance with applicable law and the accounting standards issued by the Accounting Standards Board.

It is our responsibility to form an independent opinion, based on our audit, on those statements and report our opinion to you.

We report to you our opinion as to whether the financial statements give a true and fair view in accordance with Generally Accepted Accounting Practices in Ireland, and are properly prepared in accordance with the Companies Acts 1963 to 2009. We also report to you whether in our opinion: proper books of account have been kept by the company and whether the information given in the Directors' Report and Chairman's Statement is consistent with the financial statements. In addition, we state whether we have obtained all the information and explanations necessary for the purposes of our audit and whether the company's balance sheet and Profit and Loss are in agreement with the books of account.

Basis of opinion

We conducted our audit in accordance with Auditing Standards issued by the Auditing Practices Board. An audit includes an examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgments made by

the directors in the preparation of the financial statements, and of whether the accounting policies are appropriate to the company's circumstances, consistently applied and adequately disclosed.

We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming our opinion we also evaluated the overall adequacy of the presentation of information in the financial statements.

Leased Premises

The premises are owned by the Office of Public Works. It has been assumed in the preparation of these accounts that the rent payable to the Office of Public Works will be a "Peppercorn Rent".

Opinion

In our opinion the financial statements give a true and fair view, in accordance with Generally Accepted Accounting Standards, of the state of the company's affairs as at 31st December 2010 and of its profits for the year then ended and have been properly prepared in accordance with the Companies Acts 1963 to 2009.

We have obtained all the information and explanations we consider necessary for the purposes of our audit. In our opinion proper books of account have been kept by the company. The financial statements are in agreement with the books of account.

In our opinion, the information given in the Directors' Report on page 2 and the Chairman's Statement on pages 3 to 7 is consistent with the financial statements.

NOTES TO THE ACCOUNTS FOR YEAR ENDED 31ST DECEMBER 2010

1. Accounting Policies

The significant accounting policies adopted by the company which have been applied consistently throughout the year and the preceding year are as follows :-

(a) Accounting Convention

The financial statements are prepared under the historical cost convention. The financial statements have been prepared in accordance with accounting standards generally accepted in Ireland. Accounting standards generally accepted in Ireland in preparing financial statements giving a true and fair view are those published by the Institute of Chartered Accountants in Ireland and issued by the Accounting Standards Board.

(b) Tangible Assets and Depreciation

Tangible assets are stated at cost less accumulated depreciation. Depreciation charge in the Accounts is calculated to write off the book value of each Fixed Asset during its expected normal life on a straight line basis at the following rates :-

Alterations to Leasehold Premises:	10 to 50 Years
Steinway Pianoforte:	5 Years
Computer Data System:	5 Years
Office and Catering Equipment:	5 Years
Pipe Organ:	25 Years
Amplifiers and Speaker System:	5 Years

(c) Deferred Taxation

Deferred taxation is provided under the liability method on all material timing differences to the extent that it is expected to become payable in the foreseeable future.

(d) Grant in Aid - Current

The current Grant in Aid is the subsidy receivable from the Government for the Calendar Year.


(e) Capital Grants
